OILFIELD COMPANIES RESPONSIBLE FOR SNOW REMOVAL ON ANY OF OUR ROADS WITHIN THE R.M. OF KINDERSLEY NO.290

Before snow removal is allowed, the Bylaw Enforcement requires:

- The person(s) in charge of snow removal as well as their contact information
- A list of contractors that will be doing snow removal as well as their contact information.
- A separate permit required for snow removal. These will be provided free of charge.
- ❖ Land locations as well as map showing where snow removal equipment will be working must be provided. We also require you to submit the route used to access these locations.

Once routes are approved the following applies:

- Primary weight permits are required if over secondary weight when moving equipment to locations for the purpose of snow removal.
- Companies requesting services are to make sure services have the appropriate permits in place and are told the approved route to and from location.
- ❖ We have three roads within our R.M. that are rated primary weight all the rest are rated as secondary. These roads are the Flaxcombe South, Rosana Road and the Brock (657) Grid North and South.
- Arrangements are to be made Monday to Thursday between 7:00am and 5:00pm and on Friday 7:00am and 3:00pm. This includes any moves that need to be made on holidays and weekends.
- All services are to use the approved route to get to and from location for snow removal.
- ❖ If a situation occur after hours that require special permission for use of the roads you may contact the Bylaw Enforcement.

- Dirt roads are the responsibility of the oilfield company and to be repaired and maintained during activities to your location.
- Companies are to make sure snow removal is being done correctly to reduce issues with these roads in the spring.
- Any work required from damages to the gravel roads must be done by the R.M. and costs will be billed to the oilfield company that is responsible.
- The R.M. will put restrictions on the roads within the R.M. if weather conditions become too severe to help maintain our infrastructure of safety needs. This may mean closing some or all roads such as if the temperature goes above -3 degrees Celsius as of 12:00pm. If this is the case, travel will be restricted depending on road conditions until 6:00pm (subject to change).
- The R.M. maintains all main grid roads and bus routes as required unless severe weather warrants a delay. At these times roads may be closed until they can be cleared for traffic.
- ❖ If an emergency happens please notify the Bylaw Enforcement IMMEDIATELY!
- If any roads become damaged due to negligence we will be forced to put a 10 ton limit on them until further notice.
- Anyone caught destroying a road will be responsible for the cost of repairs to the road and could be subject to a fine of up to twenty-five thousand dollars (25,000.00).
- Any authorization required must be approved by the Bylaw Enforcement.
